Requirements

- Your idea can be presented in Arabic, English, or German but the submission form must be filled out in English
- All required fields in the forms must be filled in
- Please keep the video length at max. three minutes
- Submission must not exceed 100MB
- In case you submit a YouTube video, it must comply with [YouTube Terms of Service](#)
- Your submission must be original and produced by you or the members of your group

Your video or material to be submitted may not include the following content

- Racist, or other offensive remarks
- Promotion of drug use, or other illegal behavior
- Hate speech, violence, slanderous or libelous claims, or any other actionable offenses

Your submission must not violate any rights of publicity or privacy, moral rights, or intellectual property rights, including music-related rights. Furthermore, your submission must not be defamatory, indecent, or violate any applicable laws. In case of violations of these guidelines, we will take the appropriate action and you will be disqualified from the contest.


